**PURPOSE:** to provide data and M&E support to the regional program Sustainability of Services for Key Populations in Eastern Europe and Central Asia (EECA) funded by The Global Fund. The overall goal of the regional program is contributing to reducing the HIV epidemic in the EECA region, through accelerating progress on Fast-Track by 2020 and ensuring the sustainability of HIV services for key populations in nine high impact countries of the EECA region. The program will be implemented in 2019-2021 in 14 countries of EECA: Belarus, Bosnia and Herzegovina, Georgia, Kazakhstan, Kyrgyzstan, Macedonia, Moldova, Montenegro, Romania, Russia, Serbia, Tajikistan, Ukraine, and Uzbekistan. The Officer will support research and capacity building to help the countries adapt and use science, technology and innovation for development of evidence-based country response on HIV and other related socially dangerous diseases and encourage the generation and sharing of knowledge between EECA researchers and scientists. Also the officer will provide guidelines in relation to program monitoring and evaluation by sub-recipients and coordinate activities related to improvement of national HIV service cascade data with partner organizations and national authorities.

1. Coordinate data collection activities and other M&E work within regional programs' projects
2. Analyze quarterly report of the in-country sub-recipients and aggregate program's progress towards achieving its indicators.
3. Construct HIV care cascades of the program countries and suggest activities on their systematic refinement.
4. Provide input into surveys and researches design on the basis of the current needs
5. Oversee data collection process in program countries; conduct monitoring visits to assure quality of data at the field level
6. Coordinate the process of the regional HIV/AIDS programs evaluation
7. Facilitate distribution of research results at the national and regional level.
8. Analyze HIV trends in EECA from programmatic monitoring, surveys, other data sources.
9. Collaborate with the international, national and regional HIV/AIDS data experts, organize relevant capacity building and experience sharing events.
10. Triangulate data obtained through bio-behavioral surveys, official statistics, programmatic monitoring etc. in program countries.
11. Conduct secondary data analysis of behavioral and other surveys, published in peer-review journals and reports, preparing the data for international studies and research tasks.
12. Assist in capacity building in the area of monitoring and evaluation, research, data analysis in program countries.
13. Improve professional and personal skills relevant to the job through self-training and corporate training courses;
14. Undertake other responsibilities of Research and Field Analysis and which have been discussed and agreed between the line manager and the post-holder.
