Responsibilities:

Organize and control programmer's fulfilment by partner NGOs:

- Organize grant management cycle in the frames of the MPSS subcomponent. All granting activities are to be planned, coordinated and executed with appropriate involvement of relevant Departments of Alliance, and Director: TPSM.
- Assess the capacity and prioritize the needs of potential grantees, contribute to project application evaluation submitted to the Alliance by applying organizations.
- Conclude grant agreements with partner NGOs according to the results of competitions.
- Conduct monitoring visits to NGOs to provide technical support and control the quality and efficiency of project activities.
- To identify possible gaps in program implementation and problematic issues/ outstanding situations SRs, immediately report such cases management with adequate analysis and effective adequate response.
- Coordinate efforts aimed to achieve ST indicators within the frameworks of the projects executed by sub-grantees.
- Contribute to optimization of Alliance grant procedures in accordance with current needs and new activity directions.

Provide technical assistance to Alliance grantees and partner organizations:

- Contribute to national and international HIV/AIDS activities to decrease the spread of the epidemic, search for new program approaches towards provision of medical and psycho-social support to patients getting SMT, share acquired experience within Alliance and for external audience in the course of conferences, meetings, workshops etc., and represent Alliance programs on local and international level.
- Contribute to improvement of MPSS services provided to the ST patients, with the emphasis on adherence to ST, limited use of illegal drugs of refusal to take those, better access to HIV, TB services and improved quality.
- Collect and analyze all information relevant for the successful implementation of all programmatic activities related to the MPSS. Initiate adequate responses and coordinate joint efforts within Alliance and with external partners in order to reach targets and met needs of SMT patients.
- Provide technical support to the representatives Program Department and to the organizations-recipients implementing SMT MPSS projects. Answer requests and consult sub-grantees in frames of professional knowledge and competency. Coordinate and assist the provision of technical support (including international) to the NGOs providing SMT MPSS.
- Contribute to development of respective structural, managerial, financial and program solutions to achieve improved results of the grantees' project activities.

Other responsibilities:

- Prepare documentation on Program activities, compile reports on programmatic activities, and provide regular, timely and adequate contributions into the donor reporting system.
- Maintain the interrelations among treatment and prevention programs; enable access of vulnerable populations to various harm reduction and prevention activities when necessary.
- Attend team activities, including regular meetings within the team and department.
- Prepare department's work plans and strategies regarding the implementation of SMT MPSS activities in order to guarantee its successful realization.
- Improve professional skills and develop personal abilities constantly to raise efficiency of the job while attending trainings, educational sessions, self-improvement.
- Discharge other duties imposed by the Management and required for the successful program activity of the department.

Functional authorities:

Coordinate, control and monitor the fulfillment of MPSS SMT programs implemented in all regions of Ukraine, identify the technical support needs for the respective programs and timely redirect them to Technical Support team.
