Dr. Roman Kobets, Board Chairman

Dr. Roman Kobets is a well-known and recognized expert in analysis and formation of state policy of Ukraine. He has significant experience in cooperation with public authorities, was the adviser to the Verkhovna Rada Committee (2001-2006), Minister of Education and Science (2009-2010) and Prime Minister of Ukraine (2019-2020), now he is the Advisor to Chairman of the National Agency on Corruption Prevention. In 2008-2010 he headed Information Center of External Independent Evaluation, which provided communication support for the implementation of one of the most successful reforms in Ukraine – External Independent Evaluation (EIE). From 2015 to 2018 Dr. Kobets was the Director of the European Information and Research Center at the Verkhovna Rada of Ukraine.

Roman Vasylovych is one of the main authors of Regulation of the Cabinet of Ministers of Ukraine (ed. 2020), author of a number of methods for analysis and advocacy of public policy, its information support. He has authored and mentored a number of studies in the field of public health: the attitude of stakeholders to immunization, the information crisis around the "swine flu" in 2009 (H1N1), the creation of the system of accreditation of health professionals.

Roman Kobets received his PhD at the National Academy of Sciences of Ukraine in 1996, he is the author of numerous scientific publications. From 1995 to 2015 he worked as a lecturer at the National University of Kyiv Mohyla Academy (Philosophy and Religious Studies departments), and since 2015 until now he has been a senior lecturer at the Kyiv-Mohyla School of Governance. Roman Vasylovych also teaches at the Ukrainian Catholic University.

Svetlana Antonyak

A pioneer of AIDS treatment in Ukraine, Svetlana is the Head of the HIV/AIDS clinical department of the Gromashevsky institute of Epidemiology and Infectious Diseases of the Ukrainian Academy of Medical Sciences. She has a long track record as the lead adviser to Alliance Ukraine on treatment, procurement and supply issues, and also consults to the Ukrainian PLHA Network, WHO, UN and other stakeholders. She played a leading role in the introduction and scale-up of AIDS treatment in Ukraine, took an important part in the development of training and preceptorship systems for AIDS clinicians in Ukraine and other countries of the region. Svetlana also supported the creation of the first civil society organisations representing and protecting interests of HIV positive people in Ukraine. As a trainer and resource person Svetlana is also involved in the current efforts to introduce AIDS treatment, develop non-clinical care and support services, and strengthen PLHA movements in other countries of the former Soviet Union. In addition, Svetlana is the author of some 85 scientific works on the issues of HIV/AIDS clinics and treatment.

Anya Sarang

Anya Sarang is an activist and anthropologist with deep expertise in drug policy reform, harm reduction, and gender programming. Since the late 1990s, she has dedicated herself to

supporting vulnerable communities in Russia, including people at risk of HIV, imprisonment, and violence. As the co-founder and president of the Andrey Rylkov Foundation for Health and Social Justice (ARF), she has been at the forefront of integrating harm reduction services with gender-based violence programs, mental health support, and legal aid. Her efforts have extended across Russia and Central and Eastern Europe, focusing on strengthening public health resilience in authoritarian regimes.

Anya has worked extensively on issues such as HIV, tuberculosis, and hepatitis C, advocating for access to treatment and preventive measures for communities affected by harsh drug policies. She has led and facilitated numerous research projects and strategic litigation efforts, including over 40 cases brought to the European Court of Human Rights and UN bodies.

In addition to her work in Russia, Anya established Stichting SKOSH in the Netherlands in 2017, promoting health and human rights initiatives for marginalized communities. In response to the war in Ukraine, she co-founded the Community Center for Mental Health and Harm Reduction in Tbilisi, Georgia, providing critical support to people who escaped military service and political oppression in Russia.

Her and her team work has been recognized globally, including two International Rolleston Awards for contributions to harm reduction, the Crystal of Hope Award (2011) supported by UNAIDS, and the International Award for Action on HIV/AIDS and Human Rights (2012) from Human Rights Watch and the Canadian HIV/AIDS Legal Network. These honors reflect her unwavering dedication to advancing human rights, health, and justice for marginalized communities.
